

GENERAL INFORMATION

Players are responsible for contacting the Tennis Center representatives the morning after their arrival to confirm their first scheduled match time and opponent.

Matches will be scheduled during the morning and afternoon. Entrants will be given a fifteen minute grace period before a scheduled match is declared a forfeit. Such a decision would be ratified by the head of the organizing committee. In case of inclement weather, entrants should contact the Tennis Center representatives at least an hour before their scheduled matches. If a match is cancelled due to inclement weather, play will start the following day Seeded/non-seeded players will be placed on their respective division schedules by the Tournament Director or head of events organizers. Players are responsible to report all scores to the Tennis Center representative, as a check and balance system.

FTIC rules and regulations govern all matches. When a set ends at 6-6, a 12 point tie breaker rule will take effect. There will be a ten minute warm up, a three minute break between first and second sets and a ten minute break between the second and third sets.

Each person has an ethical obligation to follow all rules. The Tournament Director reserves the right to disqualify any person for improper conduct. Proper attire is mandatory for all tournament play. Players are allowed to wear the official tournament tee-shirts before, during, or after play.

In order to establish a playing division, a minimum of eight (8) players must be entered by the respective deadline.

PLAYER ACKNOWLEDGMENT & ACCEPTANCE SECTION

1. Assumption of Risk – I acknowledge that participation in tennis tournaments may entail known and unanticipated risks, which could result in physical injury, death or property damage. I understand that such risks cannot be eliminated without jeopardizing the essential qualities of the activity. These risks may also occur as a result of my own actions, inactions or negligence, as well as actions, inactions or negligence of others, weather conditions, condition of equipment, condition of the facilities and grounds, natural disaster, national disaster, and any first aid emergency treatment, which may be administered. There may also be other risks that are not foreseeable at this time, inclusive of, but not limited to any other activities associated with the FTIC event, post tournament events organized by the FTIC, including outdoor activities, social programs, tennis clinics, or any other activities, while in Fiji, for the duration of the FTIC 2011 event.

2. Release – As part of the consideration for my participating in the activity identified above, I release, discharge, and hold harmless the Fiji Tennis Invitation Classic tournament organizers, their agents (direct or indirect), any event official or support associate, or any their party person associated with the event directly, or indirectly, inclusive but not limited to their management agents, officials, events and tournament officials, from all demands, causes of action, suits contracts, agreements, obligations, covenants, defenses, costs, liabilities and judgments, whatsoever, known or unknown, suspected or unsuspected, in contract or in tort, in law or in equity, which I might have against the FTIC, arising from my participation in the Programs. My participation in the event and tournament is strictly voluntary. I acknowledge that I have the physical ability, skills, qualifications, and training necessary to properly and safely use the property, facilities, equipment, and/or services of the Recreation Center and/or to participate in Recreation Center activities. I agree that if I have any question(s) as to what physical ability, skills, qualifications, or training is necessary for me to properly and safely use the property, facilities, equipment, and/or services of the Recreation Center and/or to participate in Recreation center activities, I will direct such question(s) to a member of the event's organizers, and obtain a documented reply for my records. I understand that my use of the property, facilities, equipment, and/or services of the Recreation Center and/or my participation in Recreation Center either in the hotel environment or on the tournament facilities present certain risks of injury including but not limited to personal injury or death. Understanding the risk involved, I knowingly and voluntarily choose to take these risks in order to use the property, facilities, equipment, and/or services of the Recreation Center and/or to participate in Recreation Center activities. I understand and agree that medical insurance is my responsibility.

3. Waiver and Indemnification – I hereby waive all claims and demands against the FTIC or any third party representatives, or agents (as could be nominated from time to time, without notice) for any loss, damage, injury (including death) or claim of any kind arising from, related to or caused by my participation in the Programs and agree to indemnify, defend, and hold harmless the FTIC organizers, their agents or nominated third party personnel from all loss, liability, damages, costs, and expenses (including actual attorney's fees) arising from or related to same. In case of emergency, accident, illness, or other incapacity which occurs while I am using the property, facilities, equipment, and/or services of the Recreation Center and/or participating in Recreation Center activities, I give my permission to be treated by a medical professional and admitted to a hospital, if necessary. I understand and agree that I am responsible for all medical and emergency expenses incurred on my behalf regardless of whether I have authorized such expenses. I forever release the FTIC event, its organizers, its nominated representatives, together with their agents, officers, and employees, from any and all claims, suits, or actions of any nature resulting from or arising out of my use of the property, facilities, equipment, and/or services while in Fiji as part of the FTIC event, or after tournament activities.

4. Photography/Video - In permitting myself to participate, I understand that my photograph/video may appear in publicity or brochures marketing the TIC programs and facilities. I understand that there are no rights granted to me to inspect or approve photographs/video prior to publication.

5. Term - I have read this Agreement and agree to be bound by its terms. This Agreement shall be effective for the FTIC tournaments in which I participate throughout the scheduled period. I am aware of the above, and have the opportunity to obtain my own travel or other relevant insurances prior to my travel to Fiji for the FTIC event, to mitigate against any risks, mentioned in the aforesaid or not, and I freely execute this document, being fully aware of all the afore said.
